Specification of electrical mains including Terms and Conditions:

1	Electrical mains will be supplied internally via the service duct where available, as shown on the master floor plan.
2	All power will be supplied terminated in a fused isolator or CEE form connector.
3	The box size of the fused isolator is approximately. – W27cm x H37cm x D19cm.
4	The mains cable to the fused isolator box will normally have a round profile cable of 32mm.
5	The fused isolator box or CEE form connection must be accessible at all times. The location of the isolator should be designed into stand plans.
6	All main sizes over 125 amp 3 phase will require Powerlock tails supplied by the custoimer to the venue connection point prior to the tenancy start date.
7	
	All cable exits and their associated isolators from the mains service duct require factoring into the overall floor/stand plans. No cable ramping is provided.
8	Temporary mains power required during the build up and break down period must be ordered separately. Venue cleaning sockets may not be utilised.
9	connectors beyond the fused isolator.
10	All distribution from the supplied main, at the mains service duct location where available to its electrical appliance, is the responsibility of the client and / or the appointed electrical contractor. Any missing or stolen service partner distribution equipment will be chargeable post event as per item 36.
11	On an occasion where the mains position is not shown on the client install drawing, a main will be installed at a central location. See 12 below.
12	Relocating a mains supply is chargeable in accordance with the rate card.
13	The rate card cost of each main includes the installation, maintenance and removal of the mains cable prior to any floor covering installation.
14	The RCD on the main switch is set between 100ma & 500mA depending on local organiser requirements. Exhibitors / their apointed electrical contractors should ensure devices are selected to prevent nuisance tripping and to ensure that final circuit protection of 30 mA is installed at the stand.
15	The rate card includes the cost of consumption during the open period of the event, but does not include the consumption during Build up or break down.
16	House / cleaning sockets are not available for exhibitor use at any time.
17	All mains energised during the build-up will be switched off at the end of each day according to the published daily tenancy end times for build-up.
18	During the open period, standard mains will be switched on and off daily, half an hour before and after open/close/s respectively. Unless 24 hour power has been requested).
19	Lighting may not be left on overnight if a 24-hour main supply has been ordred.
20	24 hour mains supplies will be switched on half an hour before the start of an event and off at the close of the last day of the event live period.
21	Orders must be placed by the deadline, noon 14 days prior to the first day of tenancy. Thereafter installation may not be possible and will be subject to a surcharge.
22	Orders are to be placed 14 days prior to the event on a mains order form, spread sheet or venue portal. A drawing must also be provided by the customer detailing the mains positions, stand orientations, and floor duct locations. Dimensoions from the centre line to the mains positions must be shown.
23	Payment is due with your order and All prices listed exclude VAT.
24	All electrical installations will be in accordance with BS7671. See the eGuide for specific clarification, UK Frequency is 50Hz.
25	A fuse replacement surcharge cost of £50. (exc Vat) will be charged per fuse. This will be charged post event.
26	A down rate mains charge will be applied for all mains which are down rated prior to the event and after the initial order was placed. The charge will be the late charge value of the new main required and a refund of 50% of the difference between this and the original charge.
27	A request to upgrade a supply after the 14 day order notice period will be priced on application due to the complexity and timing. If achivable the upgrade will attract an admin fee as per the rate card and also attract the late fee differecne in value between the original supply value ordered and the newly requested late supply value. Please contact the temporary mains service provider. Depending on the build progress, upgrade of supplies can not be guaranteed as available.
28	This internal rate card applies to internal mains only. External supplies are priced on application or via an event specific esxternal rate card issued.
29	The voltage supplied in the venue is 240V single phase or 415V three phase, with a tolerance of +6% and –10% in accordance with UK guidelines.
30	All orders placed and cancelled are refunded as follows: 2 days prior to the 1st day of the build, refunded at 50%. After this no refunds are available.
31	Live event mains are to be ordered and paid for by the main event organiser only, no 3rd party orders are permitted.
32	Any power supplies required outside the venue structure are chargeable at an enhanced rate due to the additional work required. Please contact FIL's mains provider for a quotation.
33	Any Generators and fuel required for an event must only be supplied by FIL's mains provider. Should an exhibitor require their own generator, then under exceptional circumstances a management fee will be applied by FIL. Please contact our mains provider for a quotation.
34	Surge protection is not provided on venue supplies and the venue or mains provider accepts no liability for equipment damaged as a result of a lighting in strike, switching spike variance or interruption in supply.
35	Should standby labour be required during an event then additional hourly charges will apply.
36	Common consumables-32 Amp Distribution box-£395.00, 32 Amp CEE form plug or socket-£75.00, 32 Amp HO7 cable mminimum charge 5M-£125.00, 1M of Heavy duty ramp £125.00. Other equipment priced for replacement including labour. Payment terms are 5 days from the date of invoice.


